- For Part I only, a \$750 Application fee is required at the time of your Application. If you are paying by ACH Debit or Wire Transfer, please contact Ownership Transfers for banking information.
 - o For all payment types, please include the Project name and number for reference. Applications are considered incomplete until the fee is received.
- If you are completing Part I and Part II, the Application fee is \$750 for each Part for a total of \$1,500.
- A separate Application must be completed for each Transfer, unless otherwise specified by MaineHousing, and a separate fee will apply to each Application.
- Definitions of capitalized terms used in this Application are included in Chapter 27, Transfer of Ownership Interests Rule available at www.mainehousing.org.
- Applicants will be required to provide all instruments and documents evidencing the Transfer and all consents required from third parties, limited partners, investors, etc. for the Transfer before MaineHousing consents to the Transfer.
