Arsenic Abatement Program (Arsenic)

Onetime funding authorized by the State of Maine Legislature

Arsenic Program Plan Year 2020

Funds are available from January 1, 2020 through December 31, 2020.

Grant Closing Requirements: All Arsenic PY 2020 funded jobs must be paid by December 31, 2020.

Central Heating Improvement Program (CHIP)

Funding provided by Department of Health and Human Services (DHHS)

CHIP Plan Year 2017

Funds are available from October 1, 2016 through March 31, 2021.

Grant Closing Requirements: CAAs must complete and inspect all CHIP PY 2017 funded jobs by March 31, 2021. The final PY 2017 invoice must be submitted to MaineHousing by April 30, 2021. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2020, or later by contract amendment, may not be paid.

CHIP Plan Year 2018

Funds are available from October 1, 2017 through March 31, 2021.

Grant Closing Requirements: CAAs must complete and inspect all CHIP PY 2018 funded jobs by March 31, 2021. The final PY 2018 invoice must be submitted to MaineHousing by April 30, 2021. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2021, or later by contract amendment, may not be paid.

CHIP Plan Year 2019

Funds are available from October 1, 2018 through March 31, 2022.

Grant Closing Requirements: CAAs must complete and inspect all CHIP PY 2019 funded jobs by March 31, 2022. The final PY 2019 invoice must be submitted to MaineHousing by April 30, 2022. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2022, or later by contract amendment, may not be paid.

Funds are available from October 1, 2019 through March 31, 2022.

HEAP Plan Year 2021

Funds are available from October 1, 2020 through September 30, 2021.

Grant Closing Requirements: CAAs must submit all HEAP PY 2021 invoices by September 30, 2021. The final PY 2021 invoice must be submitted to MaineHousing by October 31, 2021. Any corrections to invoices and/or additions submitted after October 31, 2021, or later by contract amendment, may not be paid.

Home Accessibility and Repair Program (HARP)

Funding authorized by the State of Maine Legislature

HARP Plan Year 2020

Funds are available from January 1, 2020 through December 31, 2020.

Grant Closing Requirements: HARP Phase 1 electronic file submissions including invoices are due to MaineHousing no later than November 16, 2020. HARP Phase 2 electronic file submissions including invoices are due to MaineHousing no later than December 29, 2020.

Lead Remediation Programs (Lead)

Funding provided U.S. Department of Housing and Urban Development (HUD)

Lead Hazard Reduction Grant Program (Federal Lead) Plan Year 2020-2023

Funds are available on February 3, 2020 and end on August 3, 2023.

Grant Closing Requirements: Federal Lead Phase 1 electronic file submissions including invoices are due to MaineHousing no later than July 1, 2023. Federal Lead Phase 2 electronic file submissions including invoices are due to MaineHousing no later than August 1, 2023.

Onetime funding authorized by the State of Maine Legislature

Lead Paint Hazard Abatement Program (State Lead) Plan Year 2018-2022

Funds are available on November 1, 2018 and end on October 31, 2022.

Grant Closing Requirements: State Lead Phase 1 electronic file submissions including invoices are due to MaineHousing no later than September 1, 2022. Federal Lead Phase 2 electronic file submissions including invoices are due to MaineHousing no later than October 28, 2022.

Low Income Assistance Plan (LIAP)

Funding provided by Maine Public Utilities Commission (MPUC)

LIAP Plan Year 2021

Funds are available from October 1, 2020 through September 30, 2021

Grant Closing Requirements: CAAs must submit all HEAP PY 2021 invoices by September 30, 2021. The final PY 2021 invoice must be submitted to MaineHousing by October 31, 2021. Any corrections to invoices and/or additions submitted after October 31, 2021, or later by contract amendment, may not be paid.

Weatherization Assistance Programs (WAP)

Funding provided by U.S. Department of Energy (DOE)

DOE Plan Year 2020

Funds are available from April 1, 2020 through March 31, 2021.

Grant Closing Requirements: CAAs must complete and inspect all DOE PY 2020 funded jobs by March 31, 2021. The final PY 2020 invoice must be submitted to MaineHousing by April 30, 2021. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2021 may not be paid.

Funding provided by Department of Health and Human Services (DHHS)

HEAP Wx Plan Year 2017

Funds are available from October 1, 2016 through March 31, 2021.

Grant Closing Requirements: CAAs must complete and inspect all HEAP Wx PY 2017 funded jobs by March 31, 2021. The final PY 2017 invoice must be submitted to MaineHousing by April 30, 2021. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2021, or later by contract amendment, may not be paid.
