

GRANT FUNDING PERIODS AND CLOSING DATE REQUIREMENTS

MaineHousing Programs administered through Energy and Housing Services (EHS)

Central Heating Improvement Program (CHIP)

Funding provided by Department of Health and Human Services (DHHS)

CHIP Plan Year 2022

Funds are available from October 1, 2021 through March 31, 2024.

Grant Closing Requirements: CAAs must complete and inspect all CHIP PY 2022 funded jobs by March 31, 2024. The final PY 2022 invoice must be submitted to MaineHousing by April 30, 2024. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2025, or later by contract amendment, may not be paid.

CHIP Plan Year 2023

Funds are available from October 1, 2022 through September 30, 2024.

Grant Closing Requirements: CAAs must complete and inspect all CHIP PY 2023 funded jobs by March 31, 2024. The final PY 2023 invoice must be submitted to MaineHousing by April 30, 2024. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2024, or later by contract amendment, may not be paid.

CHIP Plan Year 2024

Funds are available from October 1, 2023 through March 31, 2025.

Grant Closing Requirements: CAAs must complete and inspect all CHIP PY 2024 funded jobs by March 31, 2025. The final PY 2023 invoice must be submitted to MaineHousing by October 31, 2024. HEAP Plan Year 2024

Funds are available from October 1, 2023 through September 30, 2024.

Grant Closing Requirements: CAAs must submit all HEAP PY 2024 invoices by September 30, 2024. The final PY 2024 invoice must be submitted to MaineHousing by October 31, 2024. Any corrections to invoices and/or additions submitted after October 31, 2024, or later by contract amendment, may not be paid.

Home Accessibility and Repair Program (HARP)

Funding authorized by the State of Maine Legislature

HARP Plan Year 2024

Funds are available from January 1, 2024 through December 31, 2024.

Grant Closing Requirements: HARP Phase 1 electronic file submissions including invoices are due to MaineHousing no later than November 1, 2024. HARP Phase 2 electronic file submissions including invoices are due to MaineHousing no later than December 15, 2024.

Lead Remediation Programs (Lead)

Funding provided U.S. Department of Housing and Urban Development (HUD)

Lead Hazard Reduction Grant Program (Federal Lead) Plan Year 2023-2027

Funds are available on December 1, 2023 and end on November 1, 2027.

Grant Closing Requirements: Federal Lead Phase 1 electronic file submissions including invoices are due to MaineHousing no later than August 1, 2027. Federal Lead Phase 2 electronic file submissions including invoices are due to MaineHousing no later than October 15, 2027.

Funds are available from January 1, 2023 through March 31, 2025.

Grant Closing Requirements: State Lead Phase 1 electronic file submissions including invoices are due to MaineHousing no later than February 28, 2025. Federal Lead Phase 2 electronic file submissions including invoices are due to MaineHousing no later than March 15, 2025.

Lead Paint Hazard Abatement Program (State Lead) Plan Year 2024

Funds are available from January 1, 2023 through December 31, 2023.

Grant Closing Requirements: State Lead Phase 1 electronic file submissions including invoices are due to MaineHousing no later than November 1, 2023. Federal Lead Phase 2 electronic file submissions including invoices are due to MaineHousing no later than December 15, 2023.

Low Income Assistance Plan (LIAP)

Funding provided by Maine Public Utilities Commission (MPUC)

LIAP Plan Year 2024

Funds are available from October 1, 2023 through September 30, 2024

Grant Closing Requirements: CAAs must submit all LIAP PY 2024 invoices by September 30, 2024. The final PY 2024 invoice must be submitted to MaineHousing by October 31, 2024. Any corrections to invoices and/or additions submitted after October 31, 2024, or later by contract amendment, may not be paid.

MaineHousing Heat Pump Program (MHPP)

Funding provided by Department of Health and Human Services (DHHS)

MHPP Plan Year 2022

Funds are available from October 1, 2021 through March 31, 2024.

Grant Closing Requirements: CAAs must submit all MHPP PY 2022 invoices by April 30, 2024.

Funding provided by U.S. Department of Energy (DOE)

SERC Heat Pump Plan Year 2023

Funds are available from April 1, 2023 through July 31, 2024.

Grant Closing Requirements: CAAs must complete and inspect all DOE PY 2023 funded jobs by July 31, 2024. The final PY 2023 invoice must be submitted to MaineHousing by August 31, 2024. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after July 31, 2024 may not be paid.

Weatherization Assistance Programs (WAP)

DOE Plan Year 2024

Funds are available from April 1, 2024 through March 31, 2025.

Grant Closing Requirements: CAAs must complete and inspect all DOE PY 2024 funded jobs by March 31, 2024. The final PY 2023 invoice must be submitted to MaineHousing by April 30, 20254. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2025 may not be paid.

BIL-DOE Plan Year 2023

Funds are available from April 1, 2023 through March 31, 2025.

Grant Closing Requirements: CAAs must complete and inspect all BIL-DOE PY 2023 funded jobs by March 31, 2025. The final PY 2023 invoice must be submitted to MaineHousing by April 30, 2025. Any corrections to invoices, reworks, and/or additions to WAP jobs completed after March 31, 2025 may not be paid.
