SECTION 1: DIRECTIONS

The process for obtaining MaineHousing consent is simplified for certain transfers, mainly for transfers of partner/member/investor interests to Affiliates/Sponsor Affiliates, a transfer of an interest in a Qualified Rural Development Preservation Project or a transfer of less than a Controlling Interest in an Owner in projects other than Tax Credit Projects. The requirements are further outlined in Chapter 27, Transfer of Ownership Interest Rule, Part 3(A)(3)(a) and MaineHousing may allow additional transfers to be classified as simplified. If your transfer qualifies for the simplified consent process you only need to complete this Application and provide the required documentation, as outlined below, for review by MaineHousing.

Guidelines for completing and submitting Application:

- For Owners of Tax Credit Projects and other limited partnership or limited liability company owners, the Application should be submitted by all of the general partners, managers or managing members as applicable.
- Submit completed and signed Application and applicable Attachment(s), as well as any
 supporting documents, by visiting <u>MaineHousing's Ownership Transfer Page</u> and clicking
 on the secure link to upload and submit your Application. Please use the following naming
 convention:
 - o Begin each file name with the assigned MaineHousing project number.
 - Supporting documents should reference the Application item numbers to which they relate.
- A \$500 Application fee is required at the time of your Application. If you are paying by check, the check must be made payable to **Maine State Housing Authority** and mailed to: Maine State Housing Authority, ATTN: Ownership Transfer, 26 Edison Drive, Augusta, ME 04330. If you are paying by ACH Debit or Wire Transfer, please contact Ownership Transfers for banking information.
 - For all payment types, please include the Project name and number for reference. Applications are considered incomplete until the fee is received.
- A separate Application must be completed for each Transfer, unless otherwise specified by MaineHousing, and a separate fee will apply to each Application.
- Definitions of capitalized terms used in this Application are included in Chapter 27, Transfer of Ownership Interests Rule available at www.mainehousing.org.
- Applicants will be required to provide all instruments and documents evidencing the Transfer and all consents required from third parties for the Transfer before MaineHousing consents to the Transfer.
- MaineHousing may request additional information it considers necessary in reviewing this Application.

- Reserve and escrow accounts must be brought in-house if additional financing is provided, ownership or primary obligor changes, or a workout is approved.
